
2. Samruddhi Mahamarg: Mumbai-Pune

Samruddhi Mahamarg (Nagpur Expressway) by MSRDC is an under-construction 6-lane access-controlled road with a route alignment connecting Village Shivmadka in Nagpur District to Village Amne in Thane District.

It is a proposed 701-kilometer long 8-lane highway that will interface the cities of Nagpur and Mumbai in India. The highway is as of now under construction and is anticipated to be completed in phases by 2024.
